



FMCSA Urges Everyone to "Share the Road Safely" In National Safety Campaign

WASHINGTON – The U.S. Department of Transportation's Federal Motor Carrier Safety Administration (FMCSA) continues its efforts to raise public awareness so that all drivers know how to operate safely around large trucks and buses through a newly formed partnership under the *Our Roads, Our Safety* campaign.

"FMCSA is pleased to work with a group of partners that are dedicated to safety and share our agency's goal of reducing crashes, injuries and fatalities involving large trucks and buses on the road," said FMCSA Deputy Administrator Daphne Jefferson. "This important partnership amplifies the message that all drivers on the roadway must work together to ensure that everyone arrives safely at their destinations."

The <u>American Bus Association</u>, <u>AAA</u> and the <u>American Trucking Associations</u> have joined with FMCSA to amplify the *Our Roads*, *Our Safety* effort to educate all pedestrians, bicyclists, passenger vehicle drivers and commercial motor vehicle (CMV) drivers on how to better share our roadways and improve safety for all.

There are several simple actions passenger vehicle drivers should take while sharing the road with large trucks and buses:

- Stay out of the "No Zones" or blind spots at the front, back and sides of the vehicle
- Make sure they can see the driver in the mirror before safely passing
- Don't cut in close while merging in front of a CMV
- Stay back a safe distance to avoid being in the blind spot
- Anticipate wide turns and consider larger vehicles may require extra turning room
- Stay focused on the road and avoid distractions
- Lastly, be patient driving around large trucks and buses

In addition to these tips, parents and teachers can involve children aged 5-12 in highlighting the importance of road safety by participating in the <u>Road Safety Art Contest</u>. The contest allows children in kindergarten through sixth grade to use their creativity and talent to help raise awareness of how to stay safe on the roads.






MPTA Hosts Light Duty Tow School
























MNLARS Launch Date

July 7, 2017

After July 24, 2017, you will not be able to access motor vehicle records using the current records system.

On July 24, Driver and Vehicle Services (DVS) replaces ESupport with the Minnesota Licensing and Registration System (MNLARS). By now, you should have received emails on what you need to do to prepare for the transition to MNLARS and ensure you do not lose access to motor vehicle records.

Actions Required:

If you have **not submitted** an updated Records Access Agreement and/or a copy of your driver license, please do it now. When we receive that, we'll send you further information regarding self-registration to MNLARS.

If you have **submitted** the updated Records Access Agreement **and** a copy of your driver license, you should have received an email with a link to self-register and an invite token. If you have not already done the self-registration and been approved by DVS, please do it now. Then make sure all your users of motor vehicle records have reviewed the training material, have self-registered, and you have approved their registration.

Reminders:

- DURs are responsible for reviewing and approving employee's self-registration.
- DURs need to check the system to see if they have pending approvals. They will not receive email notification of a self-registration waiting for approval.

The self-registration process is complete when, after approval by the DUR, the employee receives two emails; one with a username and another with a temporary password. Employees are encouraged to log in and create a new password as soon as they receive the emails.

In case you missed it! - State Patrol seeks leads on a driver who fired shots at a tow truck on I-35E

The Minnesota State Patrol is looking for tips to find a driver who fired five to seven shots at a tow truck on Interstate 35E in St. Paul early Tuesday. At least one bullet hit the rear driver's door, but no injuries were reported.

The motive is under investigation, though the State Patrol does not believe it to be road rage. The 23-year-old tow truck driver from Richfield reported that he did not know the suspect and had no interaction with him before the runin, said Lt. Tiffani Nielson, State Patrol spokeswoman.

The incident began as the tow truck driver was stopped at a stoplight on Wheelock Parkway heading onto southbound I-35E in St. Paul. The other man got out of his minivan, approached the tow truck and started yelling at the driver, Nielson said.

The suspect "tried to argue with him, but the tow driver, based on his statement, ignored that and got on the free-way," she said.

"In between Wheelock and University Avenue, he felt his vehicle get shot five to seven times," Nielson said. The tow truck driver left the highway, stopped by Regions Hospital and called police.

Troopers found evidence that his vehicle was hit by at least one bullet. The drivers were alone in their vehicles at the time the shots were fired, Nielson said.

The suspect was driving a white 2000s Dodge or Chrysler minivan. He is described as black, in his mid-20s, about 5 feet 8 inches tall, with shoulder-length dreadlocks. Anyone with information is asked to call the State Patrol at 651-582-1509.

The State Patrol continues to investigate an unrelated instance of a motorist shooting at another vehicle in White Bear Lake in March, Nielson said Tuesday. That case began on westbound Interstate 694 and East County Line Road/Geneva Avenue North as road rage between two drivers, the State Patrol has said. The vehicles continued west and as they exited at White Bear Avenue, one motorist fired a shot at the other's vehicle, shattering a back window. Later the same day, authorities found the vehicle and driver sought in connection with the incident but made no arrests.

It's OK to Decline Inebriated Transports

When the question comes up about transporting the drunken buddy, how are you prepared to answer the officer's request?

Often it's a situation after a DUI arrest that becomes a safety issue for towers when the arresting officer asks, "Will you take the passenger's buddy with you?" (Keep in mind the officer may not let you know that the buddy is a candidate for detox.) Because you wish to serve the police, you agree to transport Mr. Companion once you're loaded and ready to go.

All is well until the officer leaves. Then, the passenger starts to get a little froggy and attempts to liberate his friend's impounded vehicle.

Being placed directly in harm's way is typically not part of any law enforcement contract. Regarding the transport of injured, intoxicated or belligerent people, what's your company's policy and procedure?

While I realize that the police department has plenty to do, asking you to take control of an intoxicated or belligerent person is putting a tower directly in harm's way. Sure, the party may seem all friendly and nice; but once the cops depart, a drunk with a purpose comes alive and may come after you.

Police officers should be in charge of and responsible for transporting passengers off the highway for the safety of the tow operator. If it's an arrest in an area where public transportation is available, taxis or a rideshare program can transport them. If the passenger is intoxicated, a better decision would be to deliver that individual to detox and not release an intoxicated person into a public place.

In one incident, a tow operator agreed to transport a pair of intoxicated males off the highway after their buddy was arrested for DUI. With the impounded vehicle on his carrier, the tower drove the buzzed buddies to a residence; while he was letting them out, the two became aggressive, pulled the towman from the cab of his tow truck, and beat him severely. His injuries included a black eye, bloody nose and bruised ribs.

Although the tower did nothing wrong, the tower chose not to press charges as he did not want to cause problems for his tow company.

If your company tows for law enforcement, I recommend that management contact your law enforcement agencies to determine if (by contract) you're required to transport intoxicated or belligerent persons? My guess is ... that's police work.
